Reaffirmation Disclosure Statement	<ul style="list-style-type: none"> • Located in "Other" documents • Requires filer to enter name of creditor • Requires to be linked to previously filed reaffirmation
Rebuttal of Presumption of Undue Hardship	<ul style="list-style-type: none"> • Located in "Other" documents • Allows filer to link to previously filed document.
Recision of Reaffirmation Agreement	<ul style="list-style-type: none"> • Located in "Other" documents • Docket text reads: Recision of Reaffirmation Agreement and Notice of Hearing • Requires a Hearing to be set • Notice to all creditors will be sent via BNC
Statement in Support of Reaffirmation Agreement	<ul style="list-style-type: none"> • Located in "Other" documents • Requires filer to enter name of creditor • Allows filer to link to previously filed Reaffirmation agreement
Statement of Good Faith	<ul style="list-style-type: none"> • Located in "Other" documents
Statement of Social Security Number (SEALED)	<ul style="list-style-type: none"> • Can be filed electronically • Automatically seals document

Tax Documents	
Request for Copy of Debtor's Tax Information	<ul style="list-style-type: none"> • Located in "Other" documents • May be filed by party in interest • Prevents discharge until complied with
Tax Documents (Sealed)	<ul style="list-style-type: none"> • Located in "Other" documents • Allows filer to submit tax documents under seal. • Will only be viewable by the court, not external users. • Only needs to be filed when requested by an interested party. • Asks filer for the year of the tax documents
