
ORDER FOR STAY RELIEF

THIS MATTER came before the Court on the Motion For Stay Relief filed by Wells Fargo Bank, N.A. on June 21, 2004. No objections to the motion were filed within the time prescribed by LBR 4001.2. The Court having reviewed the motion and good cause appearing therefor,
