BEFORE THE COURT is a motion by Ford Elsaesser, the Chapter 7 Trustee, for an order requiring Debtors to Turnover Property. The motion is supported by the Affidavit of Barry McHugh in Support of Second Motion to Amend the Petition and Motion for Turnover of Property, filed concurrently with the motion, and testimony presented at the hearing on the motion held on May 17, 2004, in Moscow, Idaho. At the hearing the Trustee amended his request to reflect that he was not asking for the turnover or possession of specific items of property, but because of subsequent events and Court action in the adversary proceeding, AP Case No. 04-6098, was requesting an order requiring Debtors to provide access to the Trustee or his representatives for the inspection and inventory of assets owned by Debtors or subject to the preliminary injunction granted in the adversary proceeding sufficient to confirm that the preliminary injunction is being complied with, and for an order requiring Debtors to disclose to the Trustee the code to an access gate installed on the road leading to Debtors' residence. Based upon the motion and evidence and good cause appearing,

ORDER FOR TURNOVER OF PROPERTY - 1

IT IS HEREBY ORDERED that Debtors shall provide access to the Trustee or his representatives for the inspection and inventory of assets on River Mountain Ranch owned by Debtors, or subject to the preliminary injunction, sufficient to confirm that assets owned by Debtors or subject to the preliminary injunction are being stored and/or maintained in an appropriate fashion. Further Debtors shall disclose to the Trustee the code to the access gate installed on the road leading to Debtors' residence.
