IT IS ORDERED that Debtors may use cash collateral in the amounts set forth in the budget attached to the Order of August 7, 2003.



accounts receivable and livestock (if any), and Debtor's farm land, to the extent necessary, to secure the amount of cash collateral used.


IT IS FURTHER ORDERED that Debtors account for receipts of receivables and calf proceeds and other income, as well as disposition thereof.




