APPLICATION OF DEBTORS-

EMPLOY COUNSEL

TO: THE HONORABLE BANKRUPTCY JUDGE:

The application of Lynn and Jeanne Ketterling, debtors-in-possession, respectfully shows as follows:

(1) Applicants were appointed by this court as debtor-in-possession in the above entitled cause pursuant to Title 11, Chapter 12, United States Code.

(2) Applicants are now managing the property of the estate.

(3) Your applicants deem it necessary that they be represented by counsel in these proceedings and wishes to employ D. Blair Clark of the law firm of Ringert Clark Chartered, Boise, Idaho, as their attorney. The services which said person is to render are:

(a) To give applicant legal advice with respect to their powers and duties in the continued operation of the business and management of the property of the debtor.

(b) To draft legal instruments necessary to the continued operation of the debtor and to assist applicant in establishing lines of credit with potential suppliers.

(c) To explain the legal position of suppliers and others extending credit to applicant during the period of administration of the debtors' estate.

(d) To prepare on behalf of applicant necessary applications, answers, orders, reports and other legal documents.

(e) To perform all other legal services for your applicant which may be necessary herein; and it is necessary for your applicant to employ an attorney for such professional services.

(4) To the best of applicants' knowledge, said person has no connection with said debtor and has no connection with any creditors of debtor. Furthermore, he represents no adverse interest to your applicant or to the estate.

(5) Applicant desires to employ such attorney on an hourly billing arrangement at the rate of \$170.00 per hour.


