
1. Subject to the approval of any application for compensation by this Court, the proposed arrangement for compensation is at the hourly rates set forth below:


NOTICE

NOTICE IS HEREBY GIVEN that any opposition to the above Application must be filed with the Clerk of the United States Bankruptcy Court, and must be served upon the undersigned counsel not later than **fourteen (14)** days from the date of this Notice. If no objection is timely filed and served, the relief requested may be granted without a hearing.

Pursuant to LBR 2002-2(c), any objection shall state briefly the grounds therefor. If an objection is filed, the opposing party must comply with LBR 2002-2(e)(2) and (3), which states, in part, that counsel for the objecting party shall be responsible for contacting the calendar clerk and obtaining a hearing date and notifying the moving party and all other parties as required by this rule. Failure to obtain and notice a hearing within thirty (30) days after filing the objection will waive the objection and allow entry on an order. Any party requesting a hearing date from the calendar clerk (or in open court) shall file the notice of hearing and related pleadings at least five (5) days prior to the scheduled hearing date.
