FACTS

- 1) Debtors filed a Small Claims Action in Bonner County Idaho. This action is against Patrick M. O'Halloran, Lena Cereghino and Outpost Corral, LLC. Case No. CV-2004-00108 and 2004-00107.
- 2) Case No. CV-2004-00107 submitted was \$2,919.02 plus costs of \$35.00 filing fee and service fee of \$59.60.
- 3) Case No. CV-2004-00108 submitted was \$327.00 plus costs of \$35.00 filing fee and service fee of \$50.00.
- 4) Hearing was scheduled before the Honorable Barbara Buchanan on Tuesday, March 23, 2004 at 9:30 a.m. Judge Buchanan requested we obtain a specific order from the U.S. Bankruptcy Court Judge giving permission for the Bankruptcy Debtors to collect this debt or any debt in Small Claims Court.

REQUEST






