MOTION OF CREDITOR REQUESTING  
EXTENSION OF TIME TO FILE PROOF OF

Northwest Children's Home, Inc., and Shriner's Hospital for Crippled Children (hereinafter "Creditors") by and through their attorneys of record, Witherspoon, Kelley, Davenport & Toole, P.S., each move this Court for an extension of the deadline to file (a) proofs of claim as required by Federal Bankruptcy Rule 3003; and (b) a complaint for determination as to the dischargeability of such claims, and as grounds for their motion state as follows:

1. Creditors have a remainder interest in a trust of which the Debtor, Frank L. Chapin, is the appointed trustee. The Creditors, as a result of such remainder interest, have an estimated, contingent and unliquidated claim against the Debtors arising from the Debtors' administration of said trust. Said claims are in part secured and in part unsecured. Copies of the proposed proof of claims are filed concurrently herewith.

2. On February 22, 2002, Debtors filed a voluntary petition under Chapter 11. The Creditors are not included in the Debtors' disclosure schedules filed as a part of that petition.


