Objection(s) is made on the following grounds:


- () The value of the property claimed exempt exceeds the amount allowed by the exemption statute. Only \$ _____ should be allowed.

- () Separate exemption(s) not claimed by debtor(s) as required by Local Rule 4003.1.

(X) Other: As regards to the following: 1991 Zieman utility trailer; 2001 Polaris 500 4x4; 1999 Polaris 500 4x4; 1975 20' Prowler Trailer. The amount claimed on Schedule C attempts to exempt \$5,200.00 on these assets. Debtors are entitled to claim \$800.00 each under IC§11-605(10) for a total of \$1,600.00. The amount claimed exceeds the statute by \$3,600.00. Exemption should be disallowed as stated and allowed as to \$1,600.00 (total) only.
