COMES NOW, Terry L. Hipwell, Debtor, and moves this court pursuant to 11 U.S.C. §1221 for an order extending the time for filing the plan under Chapter 12 of Title 11 as and for the following reasons:

1) That the bar date for filing claims for other than governmental units will not expire until December 26, 1996 and the Debtor cannot determine the amount total payment within the plan until such closure as to non-governmental entities occur.

2) The Debtor has objected to certain claims of creditors and the matter cannot be heard until December 11, 1996 and the Debtor cannot therefore fix the amount of payment until the amounts


of such claim, the subject of a portion of the Debtor's objection to claim, has been ascertained.

That the court extends the period of time for filing a plan by an additional 90 days and for such further and other relief as the court deems just and equitable.


