Robert Allen, being first duly sworn, upon oath deposes and says:

1. I am over the age of 18 and not a party to the above-referenced bankruptcy proceeding. I have personal knowledge of the matters set forth below. If called as a witness, I could and would testify competently as to such matters. I am a litigation administrator for John Deere Company ("John Deere"), West Des Moines, Iowa.

2. John Deere has made five loans to the Debtor (which loans are hereinafter collectively referred to herein as the "Loans," or as the case may be, "Loan AK," "Loan AL," "Loan AM," "Loan AN" and "Loan RD"), which loans are secured by the Collateral identified as Items A through J of John Deere's Motion for Relief from Automatic Stay.

3. As of August 20, 1996, the total balance due under the Loans was \$152,035.57. Interest continues to accrue on the Loans at a per diem rate of \$41.10.

4. The principal balance and interest due under Loan AK is \$11,117.28 and \$302.68, respectively, for a total amount due of \$11,419.96. Loan AK is secured by Item A.

5. The principal balance and interest due under Loan AL are \$3,527.36 and \$85.56, respectively, for a total amount due of \$3,612.92. Loan AL is secured by Item G.

6. The principal balance and interest due under Loan AM are \$59,517.93 and \$1,491.32, respectively, for a total amount due of \$61,009.25. Loan AM is secured by Items B, C, D, E and F.

7. The principal balance and interest due under Loan AN are \$59,359.04 and \$1,486.72, respectively, for a total amount due of \$60,845.76. Loan AN is secured by Items H and I.

8. The principal balance and interest due under Loan RD are \$18,513.96 and \$414.92, respectively, for a total amount due of \$18,928.88. Loan RD is secured by Item J.




