
PLEASE TAKE NOTICE, that pursuant to 11 U.S.C. § 362(e), the stay of 11 U.S.C. § 362(a) will terminate with respect to creditor John Deere Company ("John Deere") thirty-three (33) days from the date of John Deere's "Motion For Relief From Automatic Stay" ("Motion") unless the Court, after notice and a hearing, and within such thirty-three (33) day period, orders that the stay be continued pending a final hearing and determination under 11 U.S.C. § 362(d).

PLEASE TAKE FURTHER NOTICE that pursuant to 11 U.S.C. § 362(d) and (e) and Bankruptcy Rule 9014, such stay will automatically vacate thirty-three (33) days from the date of the Motion, unless a preliminary hearing is noticed and held within such thirty-three (33) day period. No further order of the Court will be required to vacate such stay after the thirty-three (33) day period, and no further notice is required. Vacation of the stay will allow John Deere to proceed with such remedies as are allowed by the laws of Idaho pertaining to repossession, resale, foreclosure, and the like, concerning the property described in the Motion.


