

COME NOW the debtors by and through their attorney,
Brent T. Robinson of the firm Ling & Robinson; Key Bank by and
through its attorney, Louis Uranga of the firm Uranga & Uranga;
and the Chapter 12 Trustee, Forrest P. Hymas, and with respect
to the debtors' motion to modify their confirmed Chapter 12 Plan
and the Order confirming the plan, do hereby stipulate and agree
as follows:

1. That the terms and provisions of the debtors' confirmed plan and/or order confirming the plan pertaining to the payment to be made to Key Bank in the amount of fifty (50) percent of any proceeds received from the sale of cattle in

2 excess of the monthly projection of \$18,150, shall be modified
3 to provide as follows:

4 a. With respect to the payment of one-half of the
5 excess for the month of October 2001, which is
6 the sum of \$4,793.73, debtors shall pay Key Bank
7 one-half thereof, namely, the sum of \$2,396.87;

8 b. Commencing with the month of November 2001 and
9 continuing through the month of February 2002,
10 instead of paying one-half of the excess funds
11 over \$18,150 to Key Bank, the amount of the
12 debtors' payment to the Trustee shall be
13 increased from \$1,405 to \$2,000 per month; and


14 c. Commencing with the month of March 2002, the
15 provisions for payment of one-half of the
16 proceeds in excess of \$18,150 to Key Bank shall
17 be reinstated. However, debtors reserve the
18 right to file a motion to modify the plan at that
19 time and seek to modify the terms of the plan as
20 to the provisions for payment to Key Bank, and
21 allow the Court to determine whether such motion
22 is appropriate at that juncture.

23 2. That the excess funds which otherwise would have
24 been paid to Key Bank during the months of November and December
25 2001 and January and February 2002 shall be used by the debtors
26 to satisfy outstanding accounts payable incurred for fertilizer,
27 chemicals, seed, and livestock purchases. The debtors' monthly
28 reports to the Trustee shall note how said funds are used.




