The Court having reviewed and considered the application, being fully advised in the premises and good cause appearing therefore, the Court finds that:

1. There have been no objections to the motion being granted;

3 behalf of any committee, creditor or other person.

4 3. The costs and disbursements made for and on  
5 behalf of the debtors were reasonable and necessary.


6 4. No previous application for approval of payment  
7 of the fees have been made.

8 5. The rate of compensation was approved by Order  
9 of this Court on the 28th day of September, 1999, and the  
10 reasonable value of the services rendered is reasonable; now,  
11 therefore:

12 IT IS HEREBY FOUND, ORDERED, ADJUDGED AND DECREED  
13 that attorney's fees of \$3,300.75, together with other charges  
14 in the amount of \$636.66, for a total of \$3,937.41, is  
15 reasonable compensation to be paid for professional services  
16 rendered in this case by Brent T. Robinson; and that the  
17 debtors shall and they are hereby directed to pay said sum to  
18 Brent T. Robinson as provided in debtors' Chapter 12 Plan which  
19 has been confirmed by this Court.

20 IT IS FURTHER ORDERED that the funds being held in  
21 the trust account, namely \$5,770.00, be withdrawn to the extent  
22 necessary and be applied towards said interim attorney's fees  
23 and costs.




