Debtors' Motion to Incur Secured Debt and to Modify the
Confirmed Chapter 12 Plan and Order Confirming Plan came on for
hearing on the 12th day of February, 2002. Appearing at the
hearing was the debtors and their attorney, Brent T. Robinson of
the firm LING & ROBINSON, and the Chapter 12 Trustee. The Court
having reviewed the report of the Trustee and being fully advised
in the premises now enters its Order as follows:

IT IS HEREBY ORDERED that debtors shall be and they are
hereby authorized to enter into a secured transaction with Solar

2 Farms and/or Sunstar Dairy in an amount not to exceed One Hundred
3 Forty Thousand Dollars (\$140,000), together with interest thereon
4 at the rate of seven percent (7%) per annum, said sum to be used
5 by the debtors for operating and continuing to raise the livestock
6 now on hand, to satisfy SN Servicing in its entirety and secure the
7 administrative debt owed to Solar Farms and/or Sunstar Dairy, which
8 has occurred post-petition.

9 IT IS FURTHER ORDERED that the indebtedness incurred for
10 operating expenses shall be paid on demand, but not later than
11 January 1, 2004.


12 IT IS FURTHER ORDERED that Solar Farms and/or Sunstar
13 Dairy shall be granted a first and paramount lien on debtors'
14 livestock and be entitled to obtain an assignment of SN Servicing's
15 lien on real property owned by debtors.

16 IT IS FURTHER ORDERED that the debtors shall be, and they
17 are hereby, authorized to execute whatever documents may be
18 necessary to perfect the security interest in post-petition crops
19 and crop proceeds to be granted to Solar Farms and/or Sunstar
20 Dairy, granting it a first priority lien.

21 IT IS FURTHER ORDERED that the Chapter 12 Plan previously
22 confirmed be, and the same is hereby, modified providing for the
23 monthly payments not previously made, as well as payments to be
24 made during the Year 2003, to all be due and owing December 31,
25 2003. That all other conditions of the Order confirming the Plan
26 shall remain in full force and effect.


