2. All services for which compensation is requested were performed for and on behalf of the debtors, and not on behalf of any committee, creditor or other person.
3. The costs and disbursements made for and on behalf

2 of professional services rendered on November 25, 2002, billed in
3 the amount of \$195, which amount is to be reduced by one-half, to-
4 wit: \$97.50.



6 4. No previous application for approval of payment of
7 the fees has been made.

8 5. The rate of compensation was approved by Order of
9 this Court on the 28th day of September, 1999, and the reasonable
10 value of the services rendered is reasonable; now, therefore:

11 IT IS HEREBY FOUND, ORDERED, ADJUDGED AND DECREED that
12 attorney's fees of \$3,009.50, together with other charges in the
13 amount of \$183.53, for a total of \$3,193.03, is reasonable
14 compensation to be paid for professional services rendered in this
15 case by Brent T. Robinson; and that the debtors shall and they are
16 hereby directed to pay said sum to Brent T. Robinson.

17 IT IS FURTHER ORDERED that the funds being held in the
18 trust account in the sum of \$1,832.59 be withdrawn and applied
19 towards the amount ordered to be paid herein for interim
20 attorney's fees and costs, namely the sum of \$3,193.03, and that
21 the balance of \$1,360.44 be paid by December 31, 2003.


