OBJECTION

Proof of claim is alleged to be based on a writing; no supporting documents attached to proof of claim; claim should be disallowed for distribution.

Claimant not entitled to postpetition interest; claim should be allowed in the amount of \$

No signature on claim and should be disallowed for distribution.

Claimant not entitled to priority under 11 USC 507; Priority portion of claim should be allowed as unsecured.

Claim is a duplicate of Claim No. and should be disallowed for distribution.

Claim exceeds the amount entitled to priority under 11 USC 507; \$ should be allowed as unsecured with the balance to be allowed as priority.

No evidence provided to show assignment of claim and should be disallowed for distribution.

Supporting documents attached to claim do not show perfected security interest; claim should be allowed as unsecured.

Amount of secured claim exceeds the amount allowed in the confirmed Chapter 13 plan; difference of \$ should be allowed as unsecured with balance to be allowed as secured.

Proof of claim was not timely filed ; last day to file claim was ;claim should be disallowed.

There is no class designation as to priority, unsecured and unsecured; claim should be disallowed.

Claimant is to be paid outside of the debtors Chapter 13 Plan. Therefore, claim shall be disallowed for distribution.

Secured claim is not a scheduled through debtors plan, claim should be disallowed for distribution in its entirety.
