
YOU ARE FURTHER NOTIFIED that if the objection is a matter which can be corrected by filing an amended claim, you may do so prior to the expiration of the fifteen (15) day period. Failure to file a written reply will result in the Trustee requesting that the Court enter an order disallowing the claim to the extent objected to.

**OBJECTION**

- ( ) Proof of claim is alleged to be based on a writing; no supporting documents attached to proof of claim; claim should be disallowed for distribution.
- ( ) Claimant not entitled to postpetition interest; claim should be allowed in the amount of \$
- ( ) No signature on claim and should be disallowed for distribution.
- (x) Claimant not entitled to priority under 11 U.S.C. §507; claim should be allowed as unsecured.

- ( ) Claim is a duplication of Claim No. # and should be disallowed for distribution.
- ( ) Claim exceeds the amount entitled to priority under 11 U.S.C. §507; \$ should be allowed as unsecured with the balance to be allowed as priority.
- ( ) No evidence provided to show assignment of claim and should be disallowed for distribution.
- ( ) Supporting documents attached to claim do not show perfected security interest; claim should be allowed as unsecured.
- ( ) Supporting documents attached to claim indicate a perfected security interest; claim can be recovered from secured property. Therefore, claim should be disallowed for distribution.
- ( ) Proof of claim was not timely filed; last day to file claims was July 31, 2000; claim should be disallowed.
- ( ) There is no class designation as to priority, secured, and unsecured. Claim should be disallowed for distribution.
- ( ) Claimant has amended Claim No. # by filing Claim No. #, a valid claim. Therefore, Claim No. # should be replaced by Claim No. #.
