

ORDER APPROVING  
COMPROMISE RE: K & L

The Trustee's Motion for Approval of Compromise re: K&L came on for hearing on March 5, 1999. Pursuant to Bankruptcy Rule 9019, and for good cause appearing, the motion is granted. The Trustee, John H. Krommenhoek, is authorized to enter a compromise between the Estate and K & L Development, LLC, ("K&L") whereby K&L will be distributed \$2,000.00 from disputed collateral and the estate will retain the balance of approximately \$4,600.00 from disputed collateral, free and clear of any interest of K&L. The Trustee and K&L will then dismiss with prejudice the adversary titled, *Krommenhoek v. K&L Development, LLC*, Adversary No. 97-6334, US Bankruptcy Court, District of Idaho.
