18 PLEASE TAKE NOTICE that within thirty-three (33) days of the date of this notice, The Bank
19 of New York as Trustee its successors and/or assigns, Petitioner shall ask the United States Bankruptcy
20 Court for an order granting relief from the automatic stay imposed by 11 U.S.C. § 362(a), unless a
21 party to this proceeding shall file a response to the motion and schedule, within thirty (30) days of the
22 date of this notice, a hearing with the U.S. Bankruptcy Court for the District of Idaho. Pursuant to 11
23 U.S.C. § 362(d) the automatic stay is terminated 30 days after request for relief, unless the court, after
24 notice and hearing, orders such stay continued in effect pending the conclusion of final hearing. A final
25 hearing, if any, shall commence not later than thirty (30) days after the conclusion of the preliminary

1 hearing. Failure to schedule a hearing and notify all parties, including this creditor, shall preclude
2 further objections to the motion for relief from stay.
