Also, IT IS FURTHER STIPULATED AND AGREED THAT the Stay of 11 U.S.C. 362 as against Chrysler Financial Company L.L.C., the Debtor(s), the Trustee and the following described property:


1. If Debtor(s)' loss-payee insurance on the collateral ever lapses; or

- a). No cure is made; and
- b). An Ex Parte Motion, Final Order and Affidavit are filed with this Honorable Court with copies being sent to all interested parties; and
- c). No hearing or responsive affidavit is requested or filed by Debtor(s) within five (5) days; then
- d). The Final Order may be signed by the Court to take effect

immediately.
