COMES NOW, L.D. Fitzgerald, Trustee, by and through counsel, and respectfully represents to this honorable Court as follows:

1. That Prime Time Auctions, Inc. (hereafter "Auctioneer"), has acted as Auctioneer for L.D. Fitzgerald, Trustee in Bankruptcy, for the above-named Debtor, in the above-entitled proceeding, which was filed on December 15, 1999, under the Act of Congress relating to bankruptcy, having been employed as such under authority of Order of this Court entered the 7th day of July, 2000.

2. That Auctioneer has performed valuable services for said Trustee and the estate of the above-named Debtors on a proposed percentage commission basis, regarding the sale of 2000 Volvo tractor/truck and 2 1997 Freightliner trailers with reefers. The Trustee proposes to pay Auctioneer a commission of 10% of the selling price of said vehicles, which was \$109,500.00, which would equal a commission of \$10,950.00, plus actual expenses incurred in the amount of \$1,913.88, for a total amount to be paid to Auctioneer of \$12,863.88.


3. That all the services for which compensation is requested by Auctioneer and were performed for and on behalf of said Trustee and not on behalf of any committee, creditor or other persons.

4. That because of said services rendered by Auctioneer, the Debtor's estate has been benefitted as said professionals liquidated the described property for the sum of \$109,500.00, for the estate.

WHEREFORE, L.D. Fitzgerald, Trustee, requests the Court to authorize said Trustee to pay to Auctioneer the sum of \$12,863.88 as and for compensation for services rendered as Auctioneer and expenses incurred, or such amount as to the Court may seem reasonable and just, to be paid to the Auctioneer as set forth above, as a part of the costs and expenses of the administration of the above Debtor's estate.
