
NOTICE OF MOTION REGARDING STAY

TO: CLERK OF THE U.S. BANKRUPTCY COURT,
KENNETH LYLE POPE and DEANN MAE POPE, Debtors,
STEPHEN A. MEIKLE, Attorney for Debtors,
L D FITZGERALD, Trustee

PLEASE TAKE NOTICE that within thirty-three (33) days of the date of this notice, Ameriquest
Petitioner shall ask the United States Bankruptcy Court for an order granting relief from the automatic
stay imposed by 11 U.S.C. § 362(a), unless a party to this proceeding shall file a response to the motion
and schedule, within thirty (30) days of the date of this notice, a hearing with the U.S. Bankruptcy Court
for the District of Idaho. Pursuant to 11 U.S.C. § 362(d) the automatic stay is terminated 30 days after
request for relief, unless the court, after notice and hearing, orders such stay continued in effect pending
the conclusion of final hearing. A final hearing, if any, shall commence not later than thirty (30) days
after the conclusion of the preliminary hearing. Failure to schedule a hearing and notify all parties,
including this creditor, shall preclude further objections to the motion for relief from stay.
