ORDER FOR RELIEF FROM AUTOMATIC
STAY

THIS MATTER, coming on regularly before the undersigned Bankruptcy Judge upon Motion Of Petitioner, Ameriquet , by its attorneys KARR TUTTLE CAMPBELL, for an Order annulling the stay as to any actions taken in the foreclosure of its collateral after the bankruptcy filing, and terminating the automatic stay of lien enforcement under Bankruptcy Code § 362 as it affects Petitioner and permitting Petitioner to proceed to enforce their lien against that parcel of real property described as follows:


