Joseph M. Meier of Cosho, Humphrey, Greener & Welsh, P.A., Applicant, pursuant to 11 U.S.C. §330, 331 and Rule 2016 of the U.S. Bankruptcy Rules and moves this Court for an Order authorizing and directing payment of accountant fees and costs as follows:

A. Information about the Applicant and the Application:

1. Significant dates of filing.
 - a. Date the Bankruptcy Petition was filed: November 27, 1996.
 - b. The Application requesting approval of employment was filed: December 19, 1996.
 - c. The Order approving employment of Applicant was entered by the Court on: January 16, 1997.
 - d. The identity the party represented in this proceeding is the Debtor-In-Possession.
 - e. The date services were first commenced: December 16, 1997.

f. Applicant is seeking compensation under the Bankruptcy Code under 11 U.S.C. § 331 and Rule 2016 of the U.S. Bankruptcy Rules.

2. Terms and Conditions of Employment.

a. Applicant was employed at an hourly rate of \$115.00 an hour and Debtor-In-Possession was to pay all reasonable costs incurred by Applicant;

b. Source of Compensation: Alan Pesky guaranteed the payment of the fees owed by the Debtor in addition to depositing a \$10,000.00 retainer. This was disclosed in the Application and the Order approving employment. To the extent there are proceeds available for estate to pay attorney fees, applicant has agreed to reimburse Alan Pesky for fees paid from the estate. At the current juncture there are no fees available in the estate to pay attorney fees or any other administrative expenses.

c. Identity and existence in terms controlling the use of any retainer received from any party for providing services in the case: Retainer of \$10,000.00 was received from Alan Pesky, not from the Debtor.

d. Budgetary or limitations on fees: None other than as described in #3 below;

3. Applicants professionals working on the case.

a. The names and hourly rates of applicants, professionals and para-legals who are requesting compensation are as follows:

(i) Joseph M. Meier at \$115.00 an hour;

(ii) Paralegal - abbreviated "PRL" rate is \$65.00 an hour.

c. Compensation comparable to other practitioners: The requested

compensation is in conformity with the standard rates charged in this community and are in accordance with the level and experience and expertise. In conformance with the rate, the reasonable value of the services rendered by the Applicant for the period at issue is comparable as well as the standard set forth in First Colonial Corp. of America, 544 F.2d 1291 (5th Cir. 1977);

a. Application for interim or final compensation: This application is for a interim application under 11 U.S.C. §331 for \$7,141.50 in fees and \$1,500.44 for a total of \$8,641.94.


