
**ORDER GRANTING STIPULATION
FOR RELIEF FROM THE
AUTOMATIC STAY**

The Stipulation for Relief from the Automatic Stay entered into between Portland Teachers Credit Union (hereinafter "Credit Union"), Vincent and Darci Tullock (hereinafter "Debtors"), and Bernie R. Rakozy, having come before the Court, the Court having considered the same, and with good cause appearing therefor;

NOW THEREFORE, IT IS HEREBY ORDERED that the Stipulation for Relief from the Automatic Stay should be, and is hereby APPROVED.

IT IS FURTHER ORDERED that secured creditor, Credit Union, be granted relief from the automatic stay as to the 1993 Ford F350 pickup truck, Vehicle Identification Number 2FTJW36M6PCB34870, in order to allow the Credit Union to take all steps permitted under applicable non-bankruptcy law to enforce its security interest in the vehicle, and that the Credit Union is allowed to file an unsecured claim for any deficiency.
