COMES NOW R. Sam Hopkins, Chapter 7 Trustee, and applies and respectfully represents to the court as follows:


1. Applicant is the duly appointed, qualified and acting Chapter 7 Trustee in this case.

3. Applicant wishes to retain the services of David E. Rayborn, Attorney at Law, P.O. Box 1, Pocatello, ID 83204, for representation in the recovery of potential estate assets which

may exist in connection with a state court action of the debtors, as plaintiffs, as against James T. Fees and expenses are subject to court approval.

WHEREFORE, Applicant requests leave to retain and employ David E. Rayborn, Attorney at Law, to serve as attorney in the administration of Applicant's duties as Chapter 7 Trustee in this case.


