1. Debtors are in arrears in their Chapter 13 Plan payments for the months of April, May & June 2002 . Debtor respectfully requests that the aforementioned months be deferred and that Debtor resume their regular monthly payments in August with the next payment being due on August 16, 2002
2. Debtor was temporarily out of work and his now back working full time.  
Therefore, debtor is requesting that the aforementioned payments be deferred.

4. Debtor's modified Chapter 13 Plan payments shall be as follows:
  - a. Five (5) months at \$500.00 per month;
  - b. Two (2) months deferred
  - c. Twenty-eight (28) months at \$430.00 per month;
  - d. Seven (7) months deferred
  - e. Eleven (11) months at \$430.00 per month;
  - f. Three (3) months deferred;
  - g. Four (4) months at \$200.00 per month; and
  - h. The total term of the Chapter 13 Plan shall be sixty (60) months.
