MOTION FOR MODIFICATION
OF CHAPTER 13 PLAN AFTER
CONFIRMATION; and NOTICE

COMES NOW, the Debtor, Dorn Tennis, by and through his attorney of record, C. GRANT KING, and moves this Court for an Order modifying the Chapter 13 Plan of the Debtor as more particularly set forth below:

1. Debtor is in arrears in his Chapter 13 Plan payments for the months of October, November, December, 2000, January, February, March and April 2001. Debtor respectfully requests that the aforementioned months be deferred and that Debtor resume his regular monthly payments in May with the next payment being due on May 16, 2001.
2. Debtor's is in arrears with his payments because of a change in employment. Debtor was unemployed for several months.

3. Debtor shall surrender the 1994 Nissan Sentra LE to Nissan Motor Acceptance and Nissan Motor Acceptance shall be removed from the Chapter 13 Plan.
4. Debtor respectfully request that he pay his attorney, KING LAW OFFICES, \$150.00 for this modification and consultation with client with payment coming directly from the debtor.
5. Debtor's modified Chapter 13 Plan payments shall be as follows:
 - a. Five (5) months at \$500.00 per month;
 - b. Two (2) months deferred;
 - c. Twenty-eight (28) months at \$430.00 per month; and
 - d. The total term of the Chapter 13 Plan shall be sixty (60) months.

NOTICE REGARDING APPROVAL OF MODIFICATION:

Pursuant to Rule 2002(a) (6) of the Federal Rules of Bankruptcy, the Debtor hereby gives notice that the Modification of the Debtor's Chapter 13 Plan may be approved by the Court without a hearing if no objections or request for hearing are filed with the Court and served on Debtor attorney within twenty (20) days after the service of this Motion and Notice.


