Comes now, Cosho, Humphrey, Greener & Welsh, P.A., Applicant, pursuant to 11 U.S.C. §330, 331 and Rule 2016 of the U.S. Bankruptcy Rules and hereby moves this Court for an Order authorizing payment of their fees and costs as follows:

A. INFORMATION ABOUT THE APPLICANT AND THE APPLICATION:

1. Significant dates of filing.

- a. Date the Bankruptcy Petition was filed: July 21, 1999;
- b. The Application requesting approval of employment was filed: November 18, 1999;
- c. The Order approving employment of Applicant was entered by the Court on: The Order has not been entered, a hearing on the Application has been scheduled for December 7, 1999.

- d. The identity of the party represented in this proceeding: Applicant has represented the Debtor, among other Plaintiffs in litigation instituted in the State of Idaho known as Hernandez, et.al. v. State Farm Fire and Casualty, et.al. filed in the District Court of the Fourth Judicial District in and for the State of Idaho, County of Ada, Case No. 97-601. Debtor is one of six plaintiffs in that State Court litigation against State Farm. Once Applicant was advised of the bankruptcy, it contacted the Trustee who has agreed to employ it as special counsel. The claims in the estate do not exceed the recovery so Debtor also continues to be a real party in interest.
- e. The date services were first commenced: Applicant commenced working for the Debtor on or about January 6, 1996 under agreement with the Goicoechea law offices that applicant would represent Debtor, among other Plaintiffs under a contingency fee agreement wherein Applicant and Goicoechea Law Office would collectively receive 33 1/3 % of any recovery together with reimbursement of all out of pocket expenses. Applicant further agreed to split the contingency fee between them.
- f. Subsequent to the bankruptcy being filed, Applicant was notified of the bankruptcy and has filed an Application, Nunc Pro Tunc seeking employment by the Chapter 7 Trustee as to the litigation against State Farm Insurance Company. Also, there is currently pending a Motion to Compromise Controversy pending before the Bankruptcy Court wherein the litigation with State Farm is settled, and the Debtor, among all the Plaintiffs' will receive a distribution. State Farm has requested, as part of the contract, that the amount of the distribution be held confidential. The net proceeds to be received by

the Debtor, however, even after payment of attorney fees and costs are sufficient to pay all scheduled claims of creditors and costs of administration in this case.

- g. Applicant is seeking compensation under the Bankruptcy Code under 11 U.S.C. § 331 and Rule 2016 of the U.S. Bankruptcy Rules.

2. Terms and Conditions of Employment.

- a. Applicant was employed under an agreement with the Debtor, among other Plaintiffs, as well as the Goicoechea Law Office to share a contingency fee based on 33  $\frac{1}{3}$ % of any total recovery together with payment of all reasonable costs incurred by Applicant over and above the 33  $\frac{1}{3}$ %;
- b. Source of Compensation: Award in settlement from State Farm Insurance Co.;
- c. Identity and existence in terms controlling the use of any retainer received from any party for providing services in the case: N/A;
- d. Budgetary or limitations on fees: N/A;

3. Applicants professionals working on the case.

- a. The names and hourly rates of applicants, professionals and para-legals who are requesting compensation are as follows: Attached to the Application are fees and costs incurred by the Applicant in the litigation. Since they commenced representing the Debtor, among the other Plaintiffs in the litigation as Applicants attorneys are working under a contingency fee arrangement, the hourly fee is not relevant, other than to show the substantial time and expense incurred on behalf of the Debtor, the Trustee and the other Plaintiffs in the litigation. The hours incurred are attached hereto to

demonstrate the extensive hours required in litigating this issue. As the Debtor only represented one-sixth of the Plaintiffs the total fees incurred, when reviewed on an hourly basis, would have to be allocated among the Plaintiffs. A reasonable allocation would be the total fees divided by the number of Plaintiffs. As shown by the attached Exhibit "A" the total fees and costs incurred from January 6, 1996 through November 10, 1999 exceed the sum of \$94,391.00. Therefore the Court may calculate that the contingency fee requested for fees incurred in representing the Debtor as well as the other Plaintiffs as well as special counsel for the Trustee justify the contingency award of 33  $\frac{1}{3}$ % of the recovery against State Farm.

- b. Explanation of any changes in hourly rates: N/A;
- c. Compensation comparable to other practitioners: The requested compensation based on 33  $\frac{1}{3}$ % together with reimbursement of all costs is in conformity with the standard rates charged within the community and are in accordance with the level and experience and expertise of the attorney.

4. Fee request:

- a. Application for interim or final compensation: This is an application is for a final compensation. Applicant requests that this Court enter an Order authorizing them to receive compensation based on their contingency fee and out of pocket costs from the settlement with State Farm. The only issue which must be addressed by this Court is whether Debtor and the estate should compensate Applicant for that portion of the settlement related to the Debtor's settlement with State Farm Insurance Co. Applicant seeks an order of this Court authorizing Applicant to take the initial compensation from the

settlement and remit the Debtor's net portion, as described in the Settlement Agreement, to the Debtor and the Chapter 7 estate.

- b. Dates of previous orders concerning interim compensation or expenses for this Applicant: N/A;
- c. Amount of compensation previously requested: N/A;
- d. Amount of compensation previously allowed by the Court: N/A;
- e. Amount of compensation and expenses paid to date: N/A;
- f. Amount of allowed compensation remaining unpaid to date: N/A;

5. Approval by the Trustee.

- a. Has the Trustee been given the opportunity to review the pending application:  
The Trustee has been afforded the opportunity to review the contingency fee agreement as well as the confidential settlement agreement.
- b. Has the Debtor-In-Possession approved the requested amount: N/A;

6. Is application filed less than 120 days after the Order for Relief or after a prior application?: The Application is filed in conjunction with the proposed 9019 compromise motion which is filed before this Court.

7. Period of the services or expenses covered by the application: January 6, 1996 to date.

8. Also attached hereto as Exhibit "B" are all the costs and fees incurred in this proceeding by Applicant and Goicoechea's office which total \$38,085.00 for Cosho, Humphrey, Greener & Welsh and Goicoechea's office at \$6,329.00. These are the total costs incurred for all the Plaintiffs in the litigation. A fair allocation of those costs would be to allocate one-sixth of the total to the Debtor or \$7,402.33. Again, the costs and fees attached hereto are all the costs incurred by the Applicant in the litigation.


B. CASE STATUS:

1. Status of this Chapter 7 Proceeding: Based on the disclosures of the Debtor in his Chapter 7 Schedules, there appear to be sufficient monies from the settlement proceeds to be received by Debtor to pay all claims including administrative claims in full.

WHEREFORE, Applicant requests that this Court authorize the payment to Applicant and Goicoechea Law Offices based on a contingency award of 33  $\frac{1}{3}$ % plus out of pocket costs of \$7,402.33. As numerous non-debtor plaintiffs are involved Applicant requests that the net award described in the confidential settlement Agreement be delivered to the Trustee, which net award is less the contingency fee and costs.
