

TRUSTEE'S MOTION TO  
SHORTEN TIME FOR NOTICE  
OF AUCTION

Pursuant to Bankruptcy Rule 9006(c), the Trustee moves the court for an order reducing the time required for an auction sale under Rule 2002(a) from 20 days to approximately 12-15 days' notice. The Trustee presently has the sale scheduled for October 3, 1998 in conjunction with another small bankruptcy auction. The Trustee believes that the clerk can mail the notice to provide at least 10 days' notice if not more. The reason for the request is that the property is presently being stored in the debtor's Weiser office which has been sold and the Trustee had been led to believe that the new lessee would also purchase the Weiser office furniture. This did not work out so the property needs to be disposed of but all of the debtor's other furniture and equipment was previously sold at auction. The auctioneer also has difficulty working the small auction into his schedule. Under the circumstances, it is reasonable to shorten the time and allow the sale to proceed as scheduled in conjunction with the For Rose bankruptcy case auction on October 3, 1998. No hearing is requested.
