PLEASE TAKE NOTICE That the undersigned will bring the below Renewed Request for Abandonment on for hearing before this Court at 550 W. Fort Street, 5th Floor, Boise, Idaho, on the 15th day of April, 1999, at the hour of 9:30 o'clock a.m., or as soon thereafter as counsel can be heard.

RENEWED REQUEST FOR ABANDONMENT

The trustee, Bernie R. Rakozy, renews his request, filed on or about 10/26/98 to abandon the following property:

Approximately 200+ boxes of medical records and other business records of the debtor stored at 250 N. Orchard, Boise, ID and another approximately 800+ documents stored at Mesa Records Management Systems, 7620 S. Eisenman, Boise, ID.

The property is burdensome to the estate because of the costs of storage and management of the records. In support of this renewed request, the Trustee asserts as follows:

1. All creditors and interested parties were notified on or about 10/26/98 that "pursuant to 11 USC section 554 and Bankruptcy Rule 6007 you have 15 days from the mailing of this notice to file an objection to this proposed abandonment of property. If no objection is filed, the trustee will proceed with the abandonment without further notice or hearing."

2. The only objection filed was on or about 11/10/98 by the United States of America by and through the United States Attorney office stating the debtor is required to retain the records for five years.

3. Since that time the Trustee has arranged the turnover of records to former patients and employees pursuant to Notice. The turnover is to be conducted on April 24, 1999. The Notice was mailed to all entities on the Master Mailing List on March 23, 1999 and further, the Notice was published (at least 20 days prior to April 24) in local newspapers in Boise/Nampa/Caldwell, Twin Falls, Salmon, Weiser, McCall, Ontario, and Gooding. The Trustee has made a good faith effort to allow interested parties to obtain and records relating to themselves.

4. In addition, the Trustee has been notified by the owner of the old Union Farm and Garden Building at 250 No. Orchard, Boise, Idaho, that the building has been sold and the boxes must be removed immediately. The burden of moving and storing the property further should not be borne by the estate. If a governmental agency wants the documents preserved, it is welcomed to take the documents and do so.

5. The Trustee has no control over the records at Mesa Records Management Systems and has not paid the approximately \$600 per month charge which had accrued prior to bankruptcy.


