

TRUSTEE'S MOTION TO  
SHORTEN TIME FOR NOTICE  
OF ART AUCTION

Pursuant to Bankruptcy Rule 9006(c), the Trustee moves the court for an order reducing the time required for an art auction sale under Rule 2002(a) from 20 days down to whatever time the actual mailing occurs through the clerk's office.

The Trustee presently has the sale scheduled for October 24, 1998 in conjunction with another estate and art type auction conducted by Bill Downs Auction Service. The Trustee believes that the clerk can mail the notice to provide the 20 days' notice if not more. However this motion is filed because the turn around time for the service used by the clerk is uncertain. The Debtor's art property is of the type which needs to be sold at an auction presently scheduled with similar-type property. Under the circumstances, it is reasonable to shorten the time and allow the sale to proceed as scheduled in conjunction with the auction on October 24, 1998. No hearing is requested.


