COMES NOW, The Hosac Company, Inc. and objects to the Trustee's Motion to pay certain payments to employees totaling \$5,829.89. This Motion was filed on or about August 28, 1998 by the Trustee.

The Hosac Company, Inc. is entitled to an administrative expense priority for rent incurred by the bankruptcy estate from the date the bankruptcy was filed, through the date the Trustee not only obtained rejection of the lease but also delivered possession of the premises to Landlord. Contemporaneous with this objection, Landlord has filed a motion seeking allowance of an administrative expense priority. The payment of the employees appears to be payment of expenses which have a lower priority under 11U.S.C. §507 than administrative expense priority allowed by 11 U.S.C. §507(a)(1) including the claim of



On the basis of the information currently available to The Hosac Company, Inc., and the estate's failure to pay any payments to The Hosac Company, Inc. it believes there are insufficient proceeds to pay all administrative expenses having priority from the revenues collected by the Estate creditors holding claims junior to the administrative claim of The Hosac Co., Inc. should not be paid unless the Estate has sufficient proceeds to pay all administrative expense.

On this basis the objection is lodged.
