**PETITION FOR SALES  
WITHOUT NOTICE**

The Trustee requests that the Court allow sale of the below described property of the estate without notice to creditors. This request is made for the reasons that the property is of lesser value compared to the large amount of office equipment being moved for auction. The cost and time requirements of sending notice to all creditors is burdensome because these funds are needed immediately to finance the ongoing moving costs of equipment to a central location at 250 N. Orchard in Boise, ID. The equipment must be moved immediately in order to avoid expensive office rent where the equipment is now located and to reduce the warehouse rent where the large auction will be located and conducted on September 11-12, 1998. The temporary movers and truck rentals require prompt payment and there are no other unsecured funds from which the costs can be paid. The property will be sold for its estimated fair market value. The Trustee believes these are the last sales without notice which he will request prior to the large public auction which will be extensively advertised.

1. Property to be sold:

To Idahealth Home Care, 130 Idaho St., Meridian, ID: medical library, 2 TVs, 2-two drawer lateral file cabinets, 2-five drawer lateral file cabinets, and miscellaneous office supplies and equipment. Total purchase price = \$2,100.50

To Park Center Plumbing 206 Murry St. Suite B Boise, ID: 4-snow tires, 5 small refrigerators, 5-TVS, and miscellaneous office equipment. Total purchase price = \$1,375.

2. Value of property :

The Trustee estimates that the fair market value is equal to the purchase price of both lots.

3. Method of sale:

Immediate private sales to the parties listed above.

The above sales are probably within the scope of the Preliminary Order Allowing Limited Operation filed July 10, 1998 to be terminated August 14, 1998. However, this Petition is filed as an additional authorization by the court.


