Trustee's counsel was employed to assist the Trustee who was investigating potential claims against the Department of Transportation relating to a BSU Seed Lab project and a BSU Soffit job. Multiple conferences were held with the Department of Transportation regarding these claims, and ultimately the Department of Transportation paid over to the Trustee in excess of \$3,000. In addition, the Trustee pursued a fraudulent conveyance claim against Stuart Ruderfor and Brad Wheeler. Ultimately the court approved a settlement and compromise in the sum of \$1,000 towards this claim. Finally, numerous conferences occurred with the surety company that had issued

payment and performance bonds on behalf of the Debtor because of issues relating to subrogation rights upon the bonding company's payment to unpaid subcontractors.


