1. Joinder of Parties and Amendment of Pleadings Cut-off Date: February 27, 2004.
2. Expert Testimony Disclosures:
Plaintiff identify and disclose expert reports by: March 12, 2004
Defendant identify and disclose expert reports by: May 14, 2004
All discovery relevant to experts shall be completed by: June 18, 2004
3. Number and Length of Depositions: Each party may take the deposition of an opposing party, no more than ten depositions of fact witnesses, and no more than three depositions of an opposing party's expert witnesses. Unless otherwise agreed by the parties, depositions will be limited in time to eight hours each.
4. Factual Discovery Cut-off Date: May 14, 2004
5. Dispositive Motions Filing Cut-off Date: July 16, 2004
6. Settlement Conference Date: Parties request a settlement conference after motions have been filed. The date of said conference shall be set by Judge Boyle.
7. Alternative Dispute Resolution Options: The parties elect to participate in mediation, which is scheduled for January 9, 2004. If an agreement acceptable to the parties can be reached concerning arbitration, the parties will proceed with arbitration.
8. Pretrial Conference Date: To be set by Judge Boyle.
9. Estimated Length of Bench Trial: two weeks.
