The Court has before it Micron's petition seeking \$4,876.72 in fees. In an earlier Order, the Court held that plaintiffs' failure to produce documents for over six months after leading the Court to believe that a response would be forthcoming within 30 days warranted an award of fees. Plaintiffs object that the hourly rates charged by counsel are too high. The petition includes a rate of \$220 for Kim Dockstader, a partner, and \$180 per hour for Greg Tollefson, an associate admitted to practice about five years ago. The Court finds these rates reasonable for this community, given the experience and reputation of the attorneys and their firm. The billing records are sufficient, and the total amount reasonable. The Court will therefore award the sum requested. Accordingly,

NOW THEREFORE IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Micron have \$4,876.72 from plaintiffs as attorney fees.


