
ORDER

Pending before the Court in the above-entitled matter is Defendant Juan Delgado-Delgado's motion to continu. The motion notes that plea negotiations are ongoing. The Government has no opposition to the motion.

The Court as reviewed the record in this case and finds good cause exists to grant the continuance. In light of the representations made by counsel, the Court finds the ends of justice served by granting a continuance in this case outweigh the best interests of the public and the defendant in a speedy trial. 18 U.S.C. § 3161(h)(8)(B)(iv).

Therefore, the Court **HEREBY GRANTS** Defendant's motion and **VACATES** the trial date set of May 4, 2004. The trial date is **RESET** for **Tuesday, June 1, 2004** at 1:30 p.m. in Boise, Idaho. Any and all period of delay resulting from this continuance, from the date of the filing of the Defendant's motion until the rescheduled trial date, shall be excludable time pursuant to 18 U.S.C. §§ 3161(h)(8)(A), (B)(iv).


