

IT IS FURTHER ORDERED that the pretrial shall be held on the 21st day of December, 2004, at 4:30 p.m. m., and trial shall be held on the 3rd day of January, 2005, at the hour of 1:30 p.m. m., in the Federal Courthouse, Pocatello, Idaho.
