**UNITED STATES' MOTION
 TO UNSEAL ARREST
 WARRANTS AND PUBLISH
 AN AMENDED INDICTMENT**


NOW COMES Plaintiff United States of America, by and through Thomas E. Moss, United States Attorney for the District of Idaho, and Rafael M. Gonzalez, Jr., Assistant United States Attorney for the District of Idaho, who move the Court for an order unsealing the Arrest Warrants, with one exception, and substituting an Amended Indictment, for the Indictment, which should remained sealed or redacted as stated below, in the above-referenced action. This motion is based upon the belief that unsealing and substitution or redaction of these documents is in the best interests of justice, now that the defendants have been arrested.

Defendant no. 2, R.A.B.D., has claimed to be a juvenile. Therefore, the original Indictment and warrant pertaining to him, which contains the juvenile's name, should not be published, without redaction or substitution. *See* 18 U.S.C. § 5038. The government attaches to this motion an Amended Indictment, which has deleted all references to the juvenile defendant's name, and substituted in its place, his initials. The proposed Amended Indictment is suitable for publication. In the alternative, the Court may choose to redact the original indictment, deleting all references to the juvenile by name.

WHEREFORE, the United States respectfully requests this Honorable Court to unseal the Arrest Warrants, except for the juvenile's warrant, and Amended Indictment in the above-referenced action, keeping the original Indictment sealed and unpublished.
