

**ORDER TO ALLOW ATTORNEY
OF RECORD TO WITHDRAW**

THE COURT having before it the Motion of Steven V. Richert, attorney of record for Defendant Amy Renee Fluckiger, to withdraw as attorney of record on the grounds that a conflict of interest exists by the fact that the Federal Defenders of Eastern Washington and Idaho has represented others who may have knowledge of or a relationship with Ms. Fluckiger, and through which representation may have gained confidential information which could compromise Ms. Fluckiger or the others. Based upon the Motion of present counsel for Defendant Fluckiger, it appears that a conflict of interest exists which conflict may jeopardize the attorney/client relationship, and make it inappropriate for counsel to continue to represent defendant.
