TAKE NOTICE that an **ARRAIGNMENT** on the enclosed **Superseding Indictment** for the above-named defendant is set for **September 28, 2004** in the United States Courthouse, 801 E Sherman, Pocatello, Idaho, before U.S. Magistrate Judge Larry M. Boyle

The United States Attorney's Office has advised the Court that the indictment contains no new counts or substantial amendments to the criminal counts against your client. Only technical or minor changes have been made as it pertains to your client. These amendments do not affect the maximum penalty, or implicate the defendant's right to have an additional thirty (30) days to prepare for trial under 18 U.S.C. §3161(c)(2).

The opportunity is extended to the defendant who has previously appeared in this case and who intends to plead not guilty to this superseding indictment, to enter this plea in writing rather than appearing in open court for arraignment. If the defendant wishes to proceed in this manner, the defendant and attorney shall sign the enclosed Not Guilty Plea form and **shall have it filed with the court no later than 9/23/04**, after which it will be placed in the record.

If the written plea is not filed by the above-mentioned date, it will be deemed that the defendant has not elected this option. The defendant shall appear at the place and time designated in the first paragraph of this Notice for arraignment on the Superseding Indictment for the purpose of entering an oral plea.

Regardless of the option selected by the defendant to enter a plea on the charges listed in the superseding indictment, the jury trial will remain set 11/8/04 1:30pm before U.S. District Judge B. Lynn Winmill.


