21 On or about July 10, 2004, in the District of Idaho, defendants TERRY DUANE BARNETT
22 and JASON LEE ROSE, did knowingly and intentionally distribute and possess with intent to
23 distribute 5 grams or more, or more specifically at least 37 grams of methamphetamine, its salts,
24 isomers, or salts of its isomers, or aided and abetted the same, in violation of Title 21, United States
25 Code, Sections 841(a)(1) and (b)(1)(B), and Title 18, United States Code, Section 2.

**UNLAWFUL POSSESSION OF A FIREARM
(18 U.S.C. § 922(g)(3))**

On or about July 10, 2004, in the District of Idaho, the defendant, TERRY DUANE BARNETT then being an unlawful user of a controlled substance as defined in Title 21, United States Code, Section 802, did knowingly possess in and affecting interstate commerce a firearm, to wit: a Jennings 9mm semiautomatic pistol, serial number 1510324, in violation of Title 18, United States Code, Sections 922(g)(3) and 924(a)(2).

COUNT THREE

**UNLAWFUL POSSESSION OF A FIREARM
(18 U.S.C. § 922(g)(3))**

On or about July 10, 2004, in the District of Idaho, the defendant, TERRY DUANE BARNETT then being an unlawful user of a controlled substance as defined in Title 21, United States Code, Section 802, did knowingly possess in and affecting interstate commerce a firearm, to wit: a China Norinco CSI SKS 7.63 mm rifle, serial number R21001622, in violation of Title 18, United States Code, Sections 922(g)(3) and 924(a)(2).

COUNT FOUR

**UNLAWFUL POSSESSION OF A FIREARM
(18 U.S.C. § 922(g)(3))**
