The Scheduling Conference Form/Litigation Plan shall be filed with the Clerk of Court on or before October 1, 2003.

Pursuant to Federal Rules of Civil Procedure 26 and Local Rule 16.1, fourteen (14) days after the parties have conferred on the Scheduling Conference Form/Litigation Plan, counsel

must make their initial disclosures.

On or before **October 1, 2003**, the parties must advise the Court if they wish to proceed before a Magistrate Judge by signing and returning the Notice of Availability of a United States Magistrate Judge to Exercise Jurisdiction and Requirement for Consent (see attached). If the parties do not wish to proceed before a Magistrate Judge, they must advise the Clerk of Court in writing and this matter will then be reassigned to a District Judge.

Plaintiff shall be responsible for serving this Notice of Scheduling Conference on any party not represented on the attached Clerk's Certificate of Mailing.
