Introduction

The Court has implemented a new process for identifying types of hearings in conjunction with location of hearings. The location codes appear when entering a “Notice of Hearing” or a “Notice of Hearing on Motion” event, through CM/ECF.

The purpose of the location codes are to:

- manage the court’s resources better,
- provide more and accurate information for court calendars, and
- improve service to litigants and interested parties.
