No Judge will be informed of a party's response to this notification, unless all parties have consented to the assignment of the matter to a United States Magistrate Judge. All parties are required to return this form within 60 days of receipt to the Clerk of Court. All counsel are required to e-mail this form in .pdf format to consents@id.uscourts.gov. If you are a pro se litigant or are proceeding *in forma pauperis*, you will be allowed to mail this form to the following address: U.S. District Court, 550 W. Fort St. MSC 039, Boise, ID 83724

An appeal from a judgment entered by a United States Magistrate Judge will be directly to the United States Court of Appeals for the Ninth Circuit in the same manner as an appeal from any other judgment of this district. 28 U.S.C. § 636(c); Fed.R.Civ.P. 73.

As soon as the Court receives a request for reassignment to a District Judge, the case will be so reassigned. Likewise, if all parties do not return this form within 60 days of receipt of this notice, this matter may be reassigned to a District Judge without further notice.
